REGISTRATION

1. Closing date for Delegate Registration is on 11 October 2010, Monday, 11.59p.m. (Malaysian Local Time). Any registration that comes in after 11 October 2010, Monday, 11.59p.m. (Malaysian Local Time) will not be entertained.
2. A Confirmation of your registration will be sent to you via email within three weeks upon receiving your registration form and payment stating your registration status and the amount paid. If you do not receive this confirmation in due time please email to secretariat@csm-ace.my.
